**Tuition:**

\$7,750.00 Tuition for all grades. There is a 15% discount for each additional child. This is applicable only for those paying full tuition.

\$3,875.00 Tuition for all grades. This one-time only discounted tuition is for families new to Hillel Academy.

**Payment Plan: Please select your payment plan by checking the options listed.**

\_\_\_\_\_ Semi-annual payments each in the amount of fifty percent (50%) of the total tuition due on or before **August 15, 2016** and **January 15, 2017**.

\_\_\_\_\_ Ten payments each in the amount of 10% of the total tuition but you must use automatic withdrawal and a one-time administrative fee of \$35 will be added to the first payment. Payment of each installment will be due on or before **August 15, 2016; September 15, 2016; October 15, 2016; November 15, 2016; December 15, 2016; January 15, 2017; February 15, 2017; March 15, 2017; April 15, 2017 and May 15, 2017.**

\_\_\_\_\_ To be considered for financial assistance you must fill out the Parent Financial Statement. For this online form go to [www.daytonhillel.org](http://www.daytonhillel.org), click on Admissions, then Parent Financial Statement. You will not be recommended for assistance if we do not receive your application by May 20, 2016.

**Registration deposit of \$100.00 with contracts is required. This deposit will be applied to the tuition payment if received by April 1, 2016. Registration deposits received after April 1, 2016 will not apply to tuition.**

Any check returned from the bank unpaid will be charged a minimum of \$50.00, plus any additional charges incurred by the school due to the returned check.

**Agreement:**

**Withdrawal or Dismissal:** I understand that my obligation to pay the tuition for the full academic year is unconditional and that no portion so paid or outstanding will be refunded or canceled irrespective of absence, withdrawal or dismissal from Hillel Academy. Two exceptions will be made to this policy.

- 1) If the family moves more than 50 miles from the school, the tuition will be prorated for the days the student attended, plus ten percent of the total tuition.
- 2) If the parent/guardians determine that their tuition assistance is insufficient and they have notified the school, in writing, within two weeks of receipt of the tuition assistance notification letter, they will not be responsible for the tuition for the entire year, and their deposit will be refunded.

**Only written notification received on or before, June 10, 2016, of the student's withdrawal, releases the parents/guardians from the 2016-2017 tuition responsibility, unless extended by scholarship process.**

**Rules and Regulations:** The parents/guardians and the student agree to abide by and uphold all policies, rules and regulations as adopted by Hillel Academy as set forth currently and such other policies, rules and regulations as may be promulgated hereafter by the school. The school publishes general rules and regulations in the Student Handbook, and copies are available from the front office. Disobeying the rules and regulations of the school or disruption of the school community may be deemed sufficient cause for disciplinary action, up and including dismissal, at the sole discretion of the school.

In the event of a default in making payments as herein agreed or in accordance with a converted payment plan, delinquent amounts will be subject to collection procedures. At its discretion, Hillel Academy may refuse to permit a student to continue to attend classes or to enroll for a new school year. Hillel Academy also may determine to withhold delivery of a diploma, report card or transmittal of a transcript of school records until all arrearages have been paid.
